SINCE INCEPTION IN 2010, STLF HAS PROVIDED OVER \$2,618,716 OF SUPPORT TO OVER 511 YOUTH AND THEIR FAMILIES. INCLUDING THE MATCHING FROM OUR PARTNER PROGRAMS, THIS IS OVER \$5.2M SUPPORTING YOUTH IN CRISIS. IN ADDITION, STLF PROVIDES FAMILIES WITH GUIDANCE, MENTORS AND RESOURCES TO GIVE THEM THE EMOTIONAL AND PRACTICAL SUPPORT AND STRENGTH TO SUCCESSFULLY NAVIGATE THE TREATMENT PROCESS. 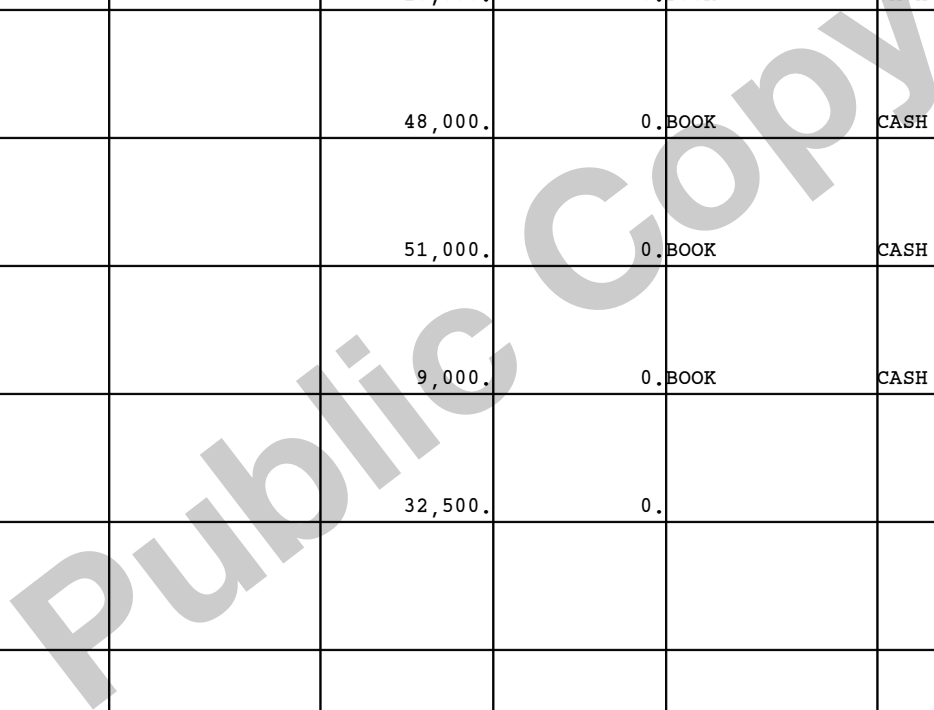
