IN FISCAL YEAR 2024 (JULY 1, 2023 - JUNE 30, 2024), SKY'S THE LIMIT FUND PROVIDED \$988,541 OF FINANCIAL ASSISTANCE FOR WILDERNESS THERAPY AND NATURE-BASED THERAPEUTIC PROGRAMS TO 116 ADOLESCENTS AND YOUNG ADULTS IN CRISIS.
